NBS VISIT 3 ELIGIBILITY CHECKLIST

Questions to ask NBS participants when they arrive for NBS Visit 3.

1. "Have you started taking insulin or oral hypoglycemic agents since we talked by phone?"

If NO: Go to question 2.

If YES: Mark "Ineligible" on question 6.

2. "Have you received supplemental oxygen during the past two weeks?"

If NO: Go to question 3.

If YES: Let the participant know that the NBS appointment will need to be rescheduled. This is because supplemental oxygen will affect study measurements. Go to question 2.1.

2.1. "Are you willing to reschedule?"

If NO: Mark "Ineligible" on question 6.

If YES: Mark "Reschedule" on question 6.

3. "Have you received blood transfusions or intravenous fluids during the past two weeks?"

If NO: Go to question 4.

If YES: Let the participant know that the NBS appointment will need to be rescheduled. This is because blood transfusions or intravenous fluids will affect study measurements. Go to question 3.1.

3.1. "Are you willing to reschedule?"

If NO: Mark "Ineligible" on question 6.

If YES: Mark "Reschedule" on question 6.

4. "Have you traveled more than 200 miles away from home during the past two weeks?"

If NO: Go to question 5.

If YES: Let the participant know that the NBS appointment will need to be rescheduled. This is because differences in the content of local drinking water will affect study measurements. Go to question 4.1.

4.1. "Are you willing to reschedule?"

If NO: Mark "Ineligible" on question 6.

If YES: Mark "Reschedule" on question 6.

5. "Have you had anything to eat or drink besides water during the past four hours?"

If NO: Mark "Eligible" on question 6.

If YES: Go to question 5.1.

5.1. Are you willing to wait to start the NBS procedures until it has been 4 hours since you have eaten?

If NO: Go to question 5.1.1.

5.1.1. Are you willing to reschedule your NBS appointment?

If NO: Mark "Ineligible" on question 6.

If YES: Mark "Reschedule" on question 6.

If YES: Ask the participant when she last ate or drank anything except water.

___ Note time when the 4-hour NBS fast will be complete: _____

___ Escort the participant to a WHI staff person to start the WHI Close-out activities until the participant has completed the 4-hour NBS fasting period.

___ After **the 4-hour fast is finished**, mark "Eligible" on question 6.

6. NBS Visit 3 Eligibility

___ Eligible → Mark "Eligible" on *Form 77, NBS Visit 3, Qx. 6.*

___ Ineligible → Mark "Ineligible" on *Form 77, NBS Visit 3, Qx. 6.*

Thank the participant and excuse her from further NBS questions.

Escort her to the WHI staff person to start the WHI Close-out visit tasks.

___ Reschedule → Reschedule the participant. Date: _____
